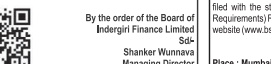
NOTE: 1. The above financial results for the quarter and year ended 31 March 2026 of Indergiri Finance Limited (the "Company") were reviewed by the Audit Committee and thereafter approved by the Board of Directors at their meeting held on 28 May 2026.

(ii) The Company, being registered with the Reserve Bank of India ("RBI") as a Non-Banking Financial Company under Section 45-IA of the Reserve Bank of India Act, 1934, is required to maintain a minimum Net Owned Fund ("NOF") of INR 500 Lakhs in terms of the Scale Based Regulation framework prescribed by the RBI vide Circular No. DOR.CE.REC.No.6013.10.01.2021-22 dated 22 October 2021.

(iii) In the early years, the Company had taken ICDN INR 750.00 Lakhs from a company with a term to repay in quarterly instalments on or before 31 March 2026. According to the revised terms, interest payable on the annual basis and repayment of principal by 22 April 2026.

(iv) In the earlier years, the Company had taken an unsecured loan from Promoter Director in 6 tranches, amounting to INR 250.00 Lakhs out of which, the company had repaid 125.00 Lakhs. The Promoter Director has revised terms of such loan as follows:

- 1. Waiver of all interest accrued retrospectively from 1 April, 2025 and to treat such loan as interest free.
2. Waiver of repayment of loan due on 1 April 2025 till date as per the earlier terms.
3. In case the Company declares any dividend during the subsistence of loan, the outstanding loan amount shall carry interest @ 10% p.a. for the relevant financial year in which such dividend is declared.
4. The tenure of the loan shall be for a term of 61 months.
5. The company will pre-pay whole or part of the loan in an event that the Promoter Director infuses funds by way of Equity via Preference Shares/Warrants to the Company.
The Company has, in accordance with Ind AS 109 "Financial Instruments" has taken the following treatment:
(a) Reversal of Interest accounted for April to September 2025 amounting to INR 14.09 Lakhs in Quarter ended 31 December 2025.
(b) Accounted a Gain of INR 126.18 Lakhs by re-measuring such loan at Fair Value in Other Income in Quarter ended 31 December 2025.
(c) Unwinding of interest of INR 17.68 Lakhs pertaining to the period 1 April, 2025 to 31 March 2026 has been included in Finance Cost.
(d) The Company has also issued a secured Non convertible debenture to East West Reserve Private Limited and East West Medical Private Limited for INR 300 lakhs, which is secured against the designated reserves, also a coupon rate of 9.75%.
(e) The Company has defaulted in repayment of interest on NCD amounting to INR 25 Lakhs.
(f) The Statement includes the audited results for financial year ended 31 March 2026 and unaudited financial results for the quarter ended 31 December, 2025, which were subject to limited review by the statutory auditors of the Company.
(vii) Previous periods' year's figures have been regrouped/reclassified wherever necessary, to conform to the current periods' years classification.
